THIS THIRD AMENDMENT TO DECLARATION OF COVENANTS AND RESTRICTIONS FOR THE ENCLAVE AT MOSS PARK is made and executed this grand day of January, 2009, by BEAZER HOMES CORP. (hereinafter referred to as "Developer").

WHEREAS, Developer, pursuant to that certain **Declaration of Covenants and Restrictions for The Enclave at Moss Park** dated July 5, 2005, and recorded on September 15, 2005 in Official Records Book 08193, Page 2281 of the Public Records of Orange County, Florida, as amended by that certain First Amendment to Declaration of Covenants and Restrictions for The Enclave at Moss Park which was dated April 10, 2006, and recorded on April 13, 2006, in Official Records Book 8586, Page 2745 of the Public Records of Orange County, Florida, and as amended by that certain Second Amendment to Declaration of Covenants and Restrictions for The Enclave at Moss Park which was dated July 14, 2006 and recorded on July 14, 2006 in Official Records Book 8753, Page 2838 of the Public Records of Orange County, Florida (hereinafter collectively referred to as the "Declaration"), did declare that certain real property more particularly described on Exhibit "A" to the Declaration was to be subject to certain covenants, conditions, restrictions, reservations and easements more particularly set forth therein, and

WHEREAS, the Developer is the owner of certain real property located in Orange County, Florida which is more particularly described in Exhibit "A" attached hereto and by this reference made a part hereof (hereinafter referred to as the "Additional Land") and,

WHEREAS, the Developer desires to annex said Additional Land into the Community (as defined in the Declaration), and

WHEREAS, the Declaration, among other things, provides, in Article VI thereof, that additional land may be annexed into the Community by the Developer so long as the Developer has Class "B" voting rights within the Community, and

WHEREAS, Developer desires now to amend the Declaration in the manner hereinafter set forth so as to annex the Additional Land described in Exhibit "A" attached hereto into the Community so that the Additional Land shall also be subject to the covenants, conditions, restrictions, reservations and easements more particularly set forth in the Declaration.

NOW, THEREFORE, for and in consideration of the premises hereof, Developer does hereby declare that the Declaration shall be, and it is hereby, changed, amended and modified as follows, to wit:

- 1. The Additional Land is annexed into the Community and is therefore subject to the provisions of this Declaration upon the recording in the Public Records of Orange County, Florida of this Third Amendment.
- 2. Except for the changes, modifications and amendments effected by this Third Amendment, the Declaration shall remain in full force and effect in strict accordance with the original terms thereof.
