# **Approval of Minutes**

## **Review of Financial Reports**

Nancy Hills reviewed the July 2014 financials with the Board of Directors. On a motion made by Marlisa Marlow and seconded by Michael Debartolo, the July financials were unanimously approved.

Nancy Hills gave the Board an up date on the delinquent accounts of the association.

# 2015 Budget and Payment Options

The 2015 proposed budget was presented to the Board. After long discussions between the Board members, it was agreed that the 2015 annual fee would be \$123.00. Upon motion duly made by Kim Holland, seconded by Michael Debartolo, the 2015 budget was unanimously approved.

Nancy Hills asked the Board whether they wished to offer a payment option and what timetable they wished to put in place. The Board wished to offer a payment option as set our below.

- Payment plan to be offered over 3 months (January to March 2015 inclusive) of \$41 per month and payments to be received by the 15<sup>th</sup> of the month.
- Payment plan to be sent with November budget pack and reminder to be sent in December.

- Signed payment plan must be returned by fax, email or hand delivered to Association Solutions by December 30<sup>th</sup>
- If the payment date is missed, the account will be removed from the payment plan and late interest will be applied to the account.
- Homeowners must have a zero balance to sign up for 2015 payment plan.

Upon motion duly made by Kim Holland, seconded by Michael Debartolo, the 2015 budget and payment plan option was unanimously approved.

# Other Business

The Board Members discussed the current violation process and would like to shorten the process is possible. Nancy Hills explained that they could remove the Courtesy Notice from the process to speed up the system by two weeks. Upon motion made by Michael Debartolo and seconded by Kim Holland, the courtesy letter is to be removed from the CCR process with immediate effect.

The Board requested that management carry out the following:-

- Request that the landscaper removes all trash before mowing and dispose of the
  trash off site. It has been noted that the landscaper filled a shopping cart at the
  front entrance with trash and did not remove from the community. This needs to
  be rectified immediately and trash needs to be disposed of correctly in the future.
- Mike Debartolo confirmed that some of the front lights are not working. Please could management arrange for the front lighting to be checked.
- Kim Holland asked that management investigate the possibility of having a temporary 'Your Speed" display system placed in the community. She believes this used to be provided free of charge by Orange County.
- The Board of Directors would like to investigate the possibility of hiring off-duty sheriffs in the community. Management to collate information and costs, and then liaise with Board as to dates and times.
