## **Review of Financial Reports**

Martyn Thorley presented the financial and delinquency reports for July 2014. Motion was made by Sherilla Lestrade, seconded by Justus Lester, and carried unanimously to approve the July 2014 Financials and Delinquent Accounts reports.

#### **Pest Control**

The Board discussed the possibility of having a regular lawn pest/fertilizer contract for the entrance and park area and decided not to proceed any further with this.

#### **New Business**

#### **Budget 2015**

Martyn Thorley presented the proposed budget for 2015 on a line by line basis explaining each item. The board discussed in detail and a motion was presented by Justus Lester to approve the budget as presented after removal of the pest control line, with the assessments being reduced to four hundred dollars for 2015 per home, with the payment split in half. First payment in January and the second in July. This was seconded by Sherilla Lestrade and carried unanimously.

At this point there was a power outage at the library and the meeting had to continue in the entrance.

## **Open Forum**

A homeowner said that if there was a power outage in the community the current telephone providers only had a battery back-up service for 10 minutes. After that it would not be possible to make even a 911 call by land-line. He asked if contact could be made with Verizon to see if they would provide a service in the community. Martyn Thorley said that he would attempt to speak to Verizon to ask them.
